[#3] Exceptional circumstances for withdrawal are at the discretion of your insurance company and may include: Illness which prevents the student from studying & close family bereavement. Evidence will be required.

(#4) It is not possible to withdraw from Accommodation at this point and therefore full Accommodation Fees will be due for the remainder of the relevant current academic year. The exception to this is where CEG fills the specific vacancy in the Accommodation created by the Student's withdrawal, in which case the amount of Accommodation fees due will be amended to reflect CEG's administrative costs or a reasonable estimate of those costs plus pro-rata Accommodation Fees for any period when the allocated Accommodation was vacant.

Refunds will be issued within 28 days of receiving full refund paperwork (unless you withdrew within the cooling off period in which case the refund will be made within 14 days) - Bank charges pertaining to any refund will be payable by the beneficiary
